

# Sri Lanka Law College General Entrance Examination

#### **Admission of Students for Academic Year 2024**

Applications are invited online from eligible candidates to sit for the General Entrance Examination for the admission of students to Sri Lanka Law College for Academic year 2024.

The application form must be completed only in English. Download instructions pertaining to making applications for the examination in the website of Department of Sri Lanka <a href="www.doenets.lk">www.doenets.lk</a> prior to completing the online application. Strictly follow the said instructions in completing the application. Incomplete applications will be rejected without prior notice.

### **Entry Qualifications**

An eligible candidate shall:

- 01. Be a citizen of Sri Lanka;
- 02. Have completed 17 years of age at the date on which the application is submitted (Accordingly, only those who are born on or before 16.08.2006 are eligible to apply);
- 03. Have two Credit Passes and one Simple Pass at one and the same sitting at the following examinations: -
  - (a) Sri Lanka General Certificate of Education (A/L) held by the Department of Examinations, Sri Lanka; or
  - (b) United Kingdom General Certificate of Education (A/L); or
  - (c) An examination that meets the criteria to be recognized as an equivalent qualification for A/L referred to in sub-paragraphs (a) and (b) above, recommended by the Department of Examinations, Sri Lanka.

Only the candidates who wish to apply based on other qualifications considered to be equivalent to General Certificate of Education (A/L) may make enquiries on 070-6759892 prior to submitting their applications.

04. Have a Credit Pass for English Language and a Credit Pass for either Sinhala Language or Tamil Language at the Sri Lanka General Certificate of Education (O/L) Examination or National General Certificate of Education Examination or at an examination considered by the Department of Examinations, Sri Lanka to be equivalent to the aforesaid examinations.

#### **General Entrance Examination**

All applicants must sit for the General Entrance Examination to be held in September 2023. The question papers for the General Entrance Examination are as follows: -

1. Language Skills - 03 hrs

2. General knowledge and General Intelligence - 03 hrs(This paper consists of two parts, each with a duration of 1 ½ hrs)

A candidate may elect to answer the General Knowledge and General Intelligence Paper in Sinhala, Tamil or English Language. If the applicant elects to answer the General knowledge and General Intelligence Paper either in Sinhala Language or Tamil Language, he/she shall elect to answer the Language Skills Paper in English Language.

If the candidate elects to answer the General knowledge and General Intelligence Paper in English Language, he/she shall elect to answer the Language Skills Paper in either Sinhala Language or Tamil Language.

The Medium of Language elected in the Application Form cannot be changed on any ground whatsoever.

#### **Examination Fees**

- (a) Applications can be submitted only online.
- (b) The examination fee is Rs. 1200/=. The examination fee must be paid only by the following methods provided in the online system: -
  - 1. Any Bank Credit Card;
  - 2. Any Bank Debit Card with the facility of internet transactions;
  - 3. Online Banking Method of Bank of Ceylon; and
  - 4. Any branch of Bank of Ceylon.
- Instructions relating to the manner of making payments using the aforesaid methods are published in the website of the Department of Examinations, under the relevant technical instructions pertaining to the examination.
- Notice of the receipt of the payment will be made via an SMS or an e-mail. The examination fee must be paid in full and applications in respect of which a lesser or higher amount than the required examination fee has been paid will be rejected. The Department of Examinations, Sri Lanka shall not responsible for any defect caused in the payment of the examination fee using the aforesaid methods.

The Law College fee of Rs. 15, 000/= must be paid in the applicant's name to the credit of A/C No. 063020073300 (Hulftsdorp Branch), Hatton National Bank in favour of the Incorporated Council for Legal Education, on or before August 16, 2023. A candidate must submit his/her application online to the Department of Examinations only after sending the relevant receipt via e-mail on <a href="mailto:entrance@sllc.ac.lk">entrance@sllc.ac.lk</a>. The applicant's name with initials, his/her National Identity Card Number and telephone number must necessarily be stated clearly in the relevant receipt. Applications will be rejected on the grounds of failure to pay the aforesaid fee properly, payment

being made in the name of another person, stating in the receipt information not belonging to the applicant etc. Moreover, it will be useful for the applicant to retain his/her receipt.

#### **Admission Card**

- 1. A soft copy including all details of applicants submitted online will be sent by the Department of Examinations to Sri Lanka Law College after the closing date. Admission Cards will be sent only to such applicants as may be approved by Sri Lanka Law College. The power of selecting candidates eligible to sit for the examination shall lie with Sri Lanka Law College.
- 2. Admission Cards are only issued online. The Department of Examinations, Sri Lanka shall, immediately after the issuing of the relevant admission cards, publish a notification to that effect in newspapers. A candidate, if any, who has not received his/her admission card must make enquiries in that regard from the Establishment Examinations Organization Branch of the Department of Examinations, Sri Lanka. The candidate must properly state the name of the examination, his/her name, National Identity Card Number and address when making such enquiries. If a candidate resides out of Colombo, he/ she may obtain a copy of the admission card by Fax. Such candidate shall send a request letter including his/her Fax Number to the Fax Number provided in the Examination Notification published by the Department of Examinations.
- 3. Any of the following documents will be accepted in order to prove the identity of the candidates:-
  - 1. National Identity Card
  - 2. A valid Passport
  - 3. A valid Sri Lankan Driver's License

Moreover, candidates must enter the examination hall without covering his/her face and ears so as to enable examination authorities to confirm their identity. Candidates who to fail to comply with such requirement will not be admitted into the examination hall. Moreover, candidates shall, from the time they enter the examination hall to the moment they leave the examination hall, remain

therein with his/her face and ears uncovered so as to enable examination authorities to recognize them.

- 4. Issuing of an admission card to a candidate shall not be considered as a recognition of his/her eligibility to sit for the examination.
- 5. A candidate shall produce his/her admission card in which his/her signature has been certified in order to sit for the examination.
- 6. Candidates shall be subject to such rules and regulations as may be imposed by the Commissioner-General of Examinations in respect of the holding of the examination and issuing of results thereof. Where a candidate has violated such rules and regulations, he/she shall be liable to any penalty as may be imposed by the Commissioner-General of Examinations.

## **Rejection of Applications**

Your application may be rejected on the following grounds. Therefore, pay attention to the same prior to submitting your application.

- 1. Submission of incomplete/ incorrect applications.
- 2. Submission of multiple applications, by one applicant.
- 3. Failure to properly send the receipt for the relevant payment to Sri Lanka Law College by e-mail.
- 4. Failure to furnish original copies of the relevant educational certificates when requested by Sri Lanka Law College.
- 5. Educational Qualifications or other qualifications having been unsatisfied at the time of making the application.

### Note

 Once the examination fee is paid, no refunds or transfers for any other examination will be made on any ground whatsoever. Similarly, the Law College fee paid by you shall also be nonrefundable.

• Penalties for submitting false information: -

The online application must be completed cautiously so as to ensure correct information is stated therein. Moreover in submitting the application online, the applicant must comply with such instructions, conditions and rules and regulations as may be provided in the online system. If an applicant is found to have violated the said instructions, conditions and rules and regulations, his/her candidature may be cancelled at any time prior to, during or after the examination.
