



**SRI LANKA LAW COLLEGE SPECIAL ENTRANCE EXAMINATION
ADMISSION OF STUDENTS FOR THE ACADEMIC YEAR 2024**

Applications are called for the Sri Lanka Law College Special Entrance Examination from those Graduates who have registered on 30.12.2020 or subsequently for the Bachelor of Laws Degree (LL.B.) in any of the foreign universities recognized by the Incorporated Council of Legal Education and have completed the relevant course.

Only those applicants, who expect to appear for the Sri Lanka Law College Final Examination to be conducted in October, 2024 may appear for the Special Entrance Examination to be conducted only in **English Language** in May, 2024.

The Application for the above examination conducted by the Department of Examination, Sri Lanka should be filled **only in English Language** and the details of access to the Application Form has been given in Number 07 of this notice.

01. Eligibility for Entrance

- I. Should be a citizen of Sri Lanka.
- II. Should have completed 17 years of age at the time of forwarding the Application. (Accordingly, only whose Date of Birth falls on or before 26.02.2007 could apply).
- III. Should have obtained Two Credit Passes and an Ordinary Pass at one and the same sitting in the Sri Lanka General Certificate of Education (Advanced Level) Examination conducted by the Department of Examination, Sri Lanka **or** in the General Certificate of Education (Advanced Level) Examination of United Kingdom **or** in any other examination within the criteria recognized as a qualification at par with the above Advance Level qualification recommended by the Department of Examinations, Sri Lanka.

Please note that other qualifications relevant to this may also be decided on exigency by the Incorporated Council of Legal Education (Should forward a certified photocopy of the results sheet with the application).

- IV. Should have obtained a Credit Pass in English Language and a Credit Pass in Sinhala or Tamil Language in the Sri Lanka General Certificate of Education (Ordinary Level) Examination or the National General Certificate of Education Examination or any examination recognized by the Department of Examinations, Sri Lanka as at par with the above examinations. Please note that other qualifications relevant to this may also be decided on exigency by the Incorporated Council of Legal Education (Should forward a certified photocopy of the results sheet with the application).

- V. Have obtained a Bachelor of Laws Degree (LL.B.) from a recognized university accepted in the United States, United Kingdom, Canada, Australia, Singapore and New Zealand **Or**
- VI. A Law Degree (LL.B.) obtained from a university that ranks in the top hundred (100) in the field of law according to the Quacquarelli Symond (QS) World University Ranking or ranking recognized by the Council, as the case may be, within any one year during the term of study of such graduates (Should forward certified photocopies of the results sheet and Degree Certificate with the application).
- VII. In addition to fulfilling the requirements in above 05, the applicant shall forward a certificate issued in the name of the applicant by an authorized authority of the relevant jurisdiction with regard to the eligibility of / permission for the applicant to practice as an attorney at law within the relevant jurisdiction where he has obtained the Laws Degree, be addressed to The Principal, Sri Lanka Law College, Colombo 12, Sri Lanka. This letter should be received to the above address before the release of the results of the Special Entrance Examination. If not the applicants' examination results would be withheld without prior notice.

02. Entrance Examination

- I. All the applicants are required to appear for the Entrance Examination scheduled to be conducted in May 2024. The Question Papers included for the Law College Special Entrance Examination which would be conducted only in English Language are as follows:

(The total duration for the above Question Papers is 3 Hours)

- II. A Seminar session will be conducted by the Sri Lanka Law College for the applicants on the syllabus of the examination.
- III. Each paper carries 50 marks and the minimum marks have to be obtained for qualifying for Law College admission is 30%.
- IV. The candidates selected for the relevant academic year would be selected in order of the highest marks obtained.

V. GENERAL CONDITIONS:

Applicants who pass the Special Entrance Examination shall appear for the specially designed Final Year Examination. If the Sri Lanka Law College recommends that there are other subjects to be completed in addition to the subjects completed in the Law Degree, such candidate should apply for and should have passed the relevant subject prior to appearing for the Final Year Examination.

03. Law College Fee and Examination Fee

- I. The duly completed Application Form published in the Sri Lanka Law College website together with the copies of the certified educational certificates and the receipts of payment of Law College Fee and Examination Fee submit to the Student Records / Law Entrance Examination Unit on or before 26.02.2024 by personally calling over.
- II. **Law College Fee of Rs. 35,000/=** shall be paid to the **Account Number 063020073300** (Hulftsdorp Branch) of the Hatton National Bank in the name of Incorporated Council of Legal Education and the relevant receipt shall be handed over with the application.
- III. In addition, the **Examination Fee of Rs.1,200/=** should be paid creditable to the Government Revenue under **Revenue Heading 20-03-02-13** of the Commissioner General of Examinations at any of the Post Offices or District/Divisional Secretariat situated in the island. The receipt received in the name of the applicant in payment in cash as such, shall be pasted irremovably in one side at the specified place in the Application Form. No Money Order or Stamps would be accepted for Examination Fee.
- IV. Applicant's name, National Identity Card Number and Telephone number shall be stated clearly on the reverse of the receipts of payments for above II, III. Please note, for no reason the Law College Fee or Examination Fee paid would be returned / transferred for another examination. Keeping copies of the Receipt of Payments in possession would be useful.

04. Examination Admission Card

- I. The Examination Admission Card will be issued by the Department of Examinations Sri Lanka 10 days prior to the Examination. The Admission Cards will be sent by post and facilities have been provided to download it from the Sri Lanka Examinations Department website. Any candidate who has not received the Admission Card shall make inquiry from the Institutional Examinations Organizing Branch of the Department of Examinations, Sri Lanka. When making such an inquiry, the Applicant's Full Name, National Identity Card Number and the address shall be correctly submitted. If the Applicant is an outstation resident, a copy of the Admission Card could be received through Fax. In that case, the Applicant should forward a request letter stating his Fax Number directed to the Fax Number 0112784232 of the Department of Examinations, Sri Lanka.

II. In proof of the identity of the Examination Candidate, any of the following documents would be accepted.

- i. National Identity Card
- ii. Valid Passport
- iii. Valid Sri Lanka Driving License

For, verification of their identity, the candidates shall enter the Examination Hall without covering their face and two ears. Otherwise, the candidate would not be allowed to enter the Examination Hall. Further, from the time of entering the Examination Hall and until the end of the examination and leaving the Hall, the candidate must remain without covering their face and two ears enabling the examination authorities to identify the candidate.

III. The signature certified Admission Card shall be submitted to appear for the examination.

- i. The Examination Candidates are bound by the rules and regulations being imposed by the Commissioner General of Examinations with regard to the conduct of examination and release of results. Any violation of the said rules and regulations, may give rise to a penalty imposed by the Commissioner General of Examinations.
- ii. Issuance of an Admission Card to a candidate shall not be considered as acceptance of the candidate fulfilling the eligibilities to appear for the examination.

05. Rejection of Application

Your application may be rejected for the following reasons. Therefore, pay serious attention prior to handing over / forwarding the application.

- I. Submission of incomplete or incorrect application.
- II. Not attaching the duly Credited Receipts with the application.
- III. Failure to submit the originals of the Educational Certificates when requested to do so by the Sri Lanka Law College.
- IV. Non fulfillment of Educational Qualifications at the time of forwarding the application.

Note

Penalty for false information: The applicant shall comply with the exam instructions, conditions and rules and regulations. If noncompliance is revealed, at any time before, in the course of or after the examination, his / her candidacy may be cancelled.

06. Method of Application

The Application Form can be downloaded from the Sri Lanka Law College website until 26.02.2024. Also, completed Application Form together with the certified copies of Educational Certificates and the Receipts of Payment of money shall be handed over personally on or before 26.02.2024 to the Student Record/ Law Entrance Examination Unit of the Sri Lanka Law College.

If any applicant to the Sri Lanka Law College Special Entrance Examination require to check their eligibility, they could make such inquiries from the Student Record/ Law Entrance Examination Unit of the Sri Lanka Law College through Telephone Numbers 011-2323759 / 011-2473119 / 070-6756892.

Applications from applicants with Special Needs should necessarily mention the nature of such need to that effect in the application and copies of relevant Medical Certificates shall be submitted along with the application.
