VACANCIES

Applications are invited for filling of the vacancies of following posts in the Superior Courts Complex Board of Management from Sri Lankan with the following qualifications.

(1) Security Assistant - Grade III (15 vacancies)

Qualifications

For external applicants:

Education

- (a) Having passed the G.C.E. (O/L) examination in six subjects in one sitting with credit passes for four subjects including.
- i. Sinhala / Tamil
 - ii. Mathematics
 - iii. English language
- (b) Having passed at least three subjects (other than the General Knowledge Test) at the G.C.E. (A/L) examination.
- (c) Any other qualifications specific to the post:
- (i) Qualifications mentioned in (a) to (b) above OR five (05) years satisfactory service in the Armed Forces or the Police Service OR 05 years' experience in Private or Government sector.
 - (ii) Physical requirements: Male - Height: 5' 2" & Chest: 32"
Female - Height: 5'

For internal applicants:

- (a) Employees of the categories of Primary Level – Skilled and Primary Level – Unskilled who possess the qualifications mentioned in (b), (c) & (d) below are eligible to apply.
- (b) Having passed G.C.E.(O/L) examination in six subjects in one sitting with credit passes for four subjects including
- i. Sinhala / Tamil
 - ii. Mathematics
 - iii. English language
- (c) Having confirmed the service in a permanent post.
- (d) At least five years' satisfactory continuous service in a permanent post on the closing date of the applications.

Age: Not less than 18 years and not more than 45 years (The upper age limit will not apply to the internal applicants)

Salary Scale: Rs. 27,910 – 10 x 300 - 7 x 350 – 12 x 600 – 12 x 710 – Rs. 49,080/=

(In addition to the above salary, government approved other allowances will be paid)

(2) Technician (Electronic/Electric) – Grade III (02 vacancies)

Qualifications

For external applicants:

Skilled Proficiency

Having obtained a proficiency certificate not less than the National Vocational Qualification (NVQ) level four (04) issued by a technical/vocational training institute accepted by the Tertiary and Vocational Education Commission, relevant to the function of each post.

- Electrician (Industrial)

For internal applicants:

Primary Level un-skilled employees in (PL I) who have completed a minimum of five (05) years working experience in the relevant field with the skills not below than the National Vocational Qualification Level two (02), proven at a trade test held by technical college/vocational training institute.

OR

Having obtained a proficiency certificates not less than the National Vocational Qualification (NVQ) level four (04) issued by a technical/vocational training institute accepted by the Tertiary and Vocational Education Commission, relevant to the function of each post.

- Electrician (Industrial)

Age: Not less than 18 years and not more than 45 years (The upper age limit will not apply to the internal applicants)

Salary Scale: Rs. 26,290 – 10 x 270 - 10 x 300 – 10 x 330 – 12 x 350 – Rs. 39,490/=

(In addition to the above salary, government approved other allowances will be paid)

(3) Technician (Building/Masonry) – Grade III (01 vacancy)

Qualifications

For external applicants:

Skilled Proficiency

Having obtained a proficiency certificates not less than the National Vocational Qualification (NVQ) level four (04) issued by a technical/vocational training institute accepted by the Tertiary and Vocational Education Commission, relevant to the function of each post.

- Field of Building (Mason)

For internal applicants:

Primary Level un-skilled employees in (PL I) who have completed a minimum of five (05) years working experience in the relevant field with the skills not below than the National Vocational Qualification Level two (02), proven at a trade test held by technical college/vocational training institute.

OR

Having obtained a proficiency certificates not less than the National Vocational Qualification (NVQ) level four (04) issued by a technical/vocational training institute accepted by the Tertiary and Vocational Education Commission, relevant to the function of each post.

- Field of Building (Mason)

Age: Not less than 18 years and not more than 45 years (The upper age limit will not apply to the internal applicants)

Salary Scale: Rs. 26,290 – 10 x 270 - 10 x 300 – 10 x 330 – 12 x 350 – Rs. 39,490/=

(In addition to the above salary, government approved other allowances will be paid)

General:

- (a) Every applicant,
 - I. Should be a Citizen of Sri Lanka
 - II. Should be physically & mentally fit to discharge the duties of the Post.
 - III. Should be excellent moral character.
- (b) All posts are permanent and non-pensionable. No transfers.
- (c) All applicants may be required to appear for an interview.
- (d) **EPF** Employee's contribution will be 10% of the salary while the employer will contribute 12% to EPF and 3% to ETF.
- (e) Selected candidates are entitled to Medical, Accident Insurance Scheme.
- (f) **Certificates:** Certified photocopies of certificates pertaining to the above qualifications and experience should be attached with the application. (Applications without the photocopies of the certificates will be rejected).
